He/She shall abide by the terms and conditions as stipulated by the Government and is liable for any action deemed fit for violation if any rule.

The individual is informed that he/she is not eligible for any TTA/joining time as the transfer is affected at his/her own request.

The dates of relief and joining should be reported promptly.
The receipt of the proceedings should be acknowledged.
